## DAVID G. DIETZE TO BE INDUCTED INTO THE INAUGURAL MOUNTAIN LAKES (NJ) HIGH SCHOOL HALL OF FAME



David G. Dietze, a 1974 graduate of Mountain Lakes High School, is one of just seven MLHS graduates to be inducted on November 21, 2014 into its inaugural Hall of Fame. The MLHS Hall of Fame is to honor scholarship, professional accomplishments, and service to others.

David and his wife, Claire Toth, reside in Summit, NJ and have two children, both of whom attend the Summit Public Schools.

Mr. Dietze, born in 1956, graduated Phi Beta Kappa, magna cum laude, and with Honors in his major, Economics, from Dartmouth College in 1978. There, he was a Rufus Choate Scholar and received five citations in English, Latin, and Greek. He studied Spanish in Granada, Spain. He pursued graduate studies at Yale University in 1978 and 1979 in Classical Studies and Political Philosophy, earning Honors work.

He earned his law degree from The Law School at The University of Chicago in 1982. He is an attorney at law and member of the Bars of New Jersey, New York, and the District of Columbia. He has practiced corporate and finance law with New York based White & Case and Washington, D.C.'s Crowell & Moring.

Mr. Dietze is actively involved in local community and charitable activities. In addition to being a member of Summit's Board of Education including Chair of its Policy Committee, he is President of the Dartmouth Club of Suburban New Jersey, past President of the Rotary Club of Summit/New Providence, past President of the Summit Tennis Club, past President of the Downtown Club, board trustee and Chair of the planning and budget committee of the Overlook Foundation, Vice President of the Summit Area Public Foundation and Chair of its investment committee, past board trustee, Treasurer, and Chair of the investment committee of the Summit Area YMCA, Co-Head Agent for Dartmouth College's Class of 1978, member of the reunion and gift committees for the University of Chicago's Law School Class of

1982, and an active member of the Suburban Chamber of Commerce and the Canoe Brook Country Club. Mr. Dietze enjoys reading, tennis, golf, skiing and paddle tennis.
